Conditions And Terms

Every participant who sends her details in our database confirms her readiness to take a gratuitous part in our enterprises:

- 6. According the conditions and terms of this Covenant the approval form Participant of the ready product (and) or advertising copy or printed issue in which is used photo and video materials with Participant's face is not needed.
- 7. In case of using the Materials after the end of the period of this Covenant the Organizer is obliged to pay the Participant remuneration amount to 10% of the sum from the total amount,

got form the Organizer by third persons in result of using the Materials.

- 8. If Participant wins prize «Miss Blondie», «I Vice-Miss Blondie» or «II Vice-Miss Blonie» the Participant and the Organizer are obligated to agree with Covenant for featuring relationships with duration one year respective with the conditions of this competition.
- 9. The Participants are required to know and obey the conditions and terms in this Covenant.
- 10. The period of this covenant begins form the moment of signature to 31st December 2010.
